#### **REGISTRATION FEES**

#### **GENERAL BUSINESS**

- 1. SNZ have issued a New Constitution for Regions which aligns with the New SNZ Constitution that was passed recently at a Special General Meeting.
- 2. SNZ have asked that this New Regional Constitution be discussed and voted on by all the Regions.

# Query's from A Bates;

- a) Most of the changes are minor technical changes and are fine in the opinion of HPK;
- b) However, there are concerns regarding two sections, firstly;
- c) If the new Section 6.1 is passed, then there is ambiguity with Section 5, Powers and Obligations of the Region, and specifically 5.1(e) as this does not classify the members of Member Clubs but does align with the existing Constitutions wording of Section 6. Secondly;
- d) Section 6, specifically the new 6.1.



- e) This section now states that (b) Members of Member Clubs are now Members of SCM.
- f) As such they are to become Members of Swimming Counties Manukau without their knowledge or consent.
- g) This is believed to be unlawful under contract law, as one body cannot just make a member of another body a member of themselves without that 'third' party (the Member) knowing and agreeing to it.
- h) Under HPK's membership form the contract is between the Club, SNZ and the Applicant/Member not SCM.
- SCM cannot just make these members their members with a Constitutional change without the knowledge of the person, especially so when the majority of all our member are minors.
- j) We would not be abiding by the Privacy Act either if information was to be passed between bodies without the knowledge or authorisation of the individual.
- k) A Club in the Swimming Wellington Region has received Legal advice which some elements are related to our Region and we should take this into consideration when making any decision.
- I) Alastair to send the Legal Advice to all delegates post meeting for their information.
- m) A discussion then pursued on what could be our next steps;

Proposed that the New Board should discuss with SNZ and have answers to the concerns raised along with a proposal for an SGM of Swimming Counties Manukau before the SNZ AGM on the  $29^{th}$  September 2019.
